ADOPTING THE STATUTES.

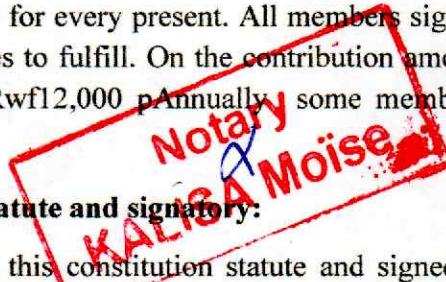
The following minutes were adopted by the participants after understanding and acceptance of statute:

1. Approval of members' list details and contributions amount

The participants have got time for explanations and requirements for being member in Imboni Organization and obligations. After consulting the statute of this constitution (*Article 4: members are the signatories of the Constitution of the organization. Ordinary members are physical persons who, upon request and after subscription to this constitution, are approved by the General Assembly. Loss of membership is caused by death, voluntary resignation, exclusion or dissolution of the Organization. Voluntary resignation is written and addressed to the President of the Executive Committee who submits it for approval by the General Assembly*). And (General Meeting) members have agreed to engage and sign statute, this gives automatic membership for every present. All members signed the statute minutes as requirements and compliances to fulfill. On the contribution amount, members agreed to be 1000Rwf per month or Rwf12,000 pAnnually, some members paid their contribution cash.

2. Approval of organization constitution statute and signatory:

The participants agreed the contents of this constitution statute and signed with present members after explanation of details in article from 1 to 8. They agreed that, this final copy should be shared as hard copies to every member's email both hard copy file in office of Imboni Organization, the meeting advised to the Secretary to keep that hard copy document as fundamental document to be filed and availed in the office premises.



3. Voting committee (s) and assigning responsibilities (ELECTING LEADERS OF ORGANS).

The committees were elected under the available positions by members themselves. And the responsibilities of both committees were detailed in statutes and other internal documents (Like: internal rules & regulations and code of conducts as detailed) respectively. The meeting agreed up on one year term all the elected members, then after one year election again for the compliance prescriptions under the **Article 8** of the statute but also in general assemble meeting.
